



## **City Meeting September 12th, 2019**

The Adams Board of Commissioners met in regular session on Thursday, September 12th 2019, at 7:00 p.m. in the Bell School Auditorium. Mayor Mantooth and Commissioner Boisseau were present.

### **Item 1: Open with A Prayer**

The meeting was called to order and Robert Evans lead in prayer. Mantooth requested all in attendance to stand for the Pledge of Allegiance.

### **Item 2: Minutes**

Minutes of the August 8th meeting were read. Mantooth asked if there were any additions or corrections. With no additions or corrections, the minutes were approved as read.

### **Item 3: Finances**

The financials were presented. Mantooth made a motion to approve the financials. Boisseau seconded the motion and the financials were approved. A rollcall was made; Mayor Mantooth, “Aye” and Commissioner Boisseau, “Aye”.

### **Item 4: Ordinance 2019-023**

Boisseau made a motion to approve Ordinance 2019-023. Mantooth seconded the motion and Ordinance 2019-023 was approved. A rollcall was made; Mayor Mantooth, “Aye” and Commissioner Boisseau “Aye”.

### **Item 5: Rescind Resolution 2019-020**

The City of Adams does not have an agricultural section in the Zoning Ordinance. Robertson County will handle all rezoning of agricultural properties inside City Limits. Boisseau made a motion to rescind Resolution 2019-020. Mantooth seconded the motion and Resolution 2019-020 was rescinded. A rollcall was made; Mayor Mantooth, “Aye” and Commissioner Boisseau, “Aye”.

### **Item 6: Concession Stand Air Conditioner**

The air conditioner in the concession stand went out. The board discussed having Josh Bagby give a quote on knocking out a hold for a wall unit for the concession stand instead of replacing the outside unit.

### **Item 7: Gateway Paranormal Proposal**

The Gateway Paranormal team has sent a proposal to the City in regards to revisiting the grounds and school. They will be selling 15 tickets to investigate the school and cabin. The team and the City will split the proceeds 60/40 (The City will receive sixty percent and the team will receive forty percent of sales). The board is allowing Gateway Paranormal to host the event as long as they have insurance and someone from the City stays on the grounds with them during the investigation.

### **Other business:**

The duct cleaning for the air vents will be postpone due to having to buy a new air conditioner for the Bell School. The board discussed the ADA ramps and chairlifts again and are awaiting to receive information from Roger Matchett with Matchett and Associates. The City is still having issues with citizens parking on the septic tank at the pavilion. Some discussion was made on putting a temporary barricade around it until a decision is made on how to resolve the issue.

There being no further business, Mayor Mantooth moved to adjourn. Commissioner Boisseau seconded the motion. Meeting adjourned at 7:38 p.m.
