



City Meeting February 10th 2022

The Adams Board of Commissioners met in regular session, at 7:00 p.m. in the Bell School Auditorium. Mayor Evans, Vice Mayor Hall, and Commissioner Baird were present

Item 1: Open with A Prayer

The meeting was called to order and Donovan Tucker lead in prayer. Evans requested all in attendance to stand for the Pledge of Allegiance.

Item 2: Minutes

Minutes of the January meeting were presented. Evans asked if there were any additions or corrections. With the no additions or corrections, the minutes were approved.

Item 3: Financials

The financials were presented for January. Baird made a motion to approve the financials. Hall seconded the motion and the financials were approved. All in favor, none opposed.

Item 4: Paving

Item 5: Ord No 2022-035

Item 8: Randy Riley Water Board

Baird made a motion to appoint Randy Riley for the West Robertson Water Authority board. Hall seconded it. A roll call was made; Evans, "Aye", Baird "Aye", Hall "Aye". Passed 3-0.

Item 9: Impact Pyro

Impact Pyro informed the City Recorder that because of inflation, the firework show would increase by 40%. Due to the increase, the city will need to bid out. All in favor. None opposed.

Item 10: Tornado Siren

Mayor Evans talked with Clint Zack about the serve weather sirens. The company, Motorola, has a state contract with Tennessee. RapidWarn are only sold by the company. City Recorder was

advised to start the application for the TEMA grant to get reimbursed for the funds. All in favor. None opposed.

Item 11: Sealing Parking Lot

A quote was received by Bobby Green to seal the rest of the parking lot at Bell School. The quote was for \$5,000. A motion was made by Hall. Seconded by Baird. A roll call was made; Evans, “Aye”, Baird “Aye”, Hall “Aye”. Passed 3-0.

Item 12: Pot Holes

Mayor Evans made a motion to hire Tim Hulsey to fix pot holes in the city. Hall seconded it. All in favor. None opposed.

Fire Department – Ray Brown was not present.

There being no further business, Mayor Evans moved to adjourned. Commissioner Baird seconded the motion. Meeting adjourned at 7:37 pm.
