### **Fire Department-**

Chief Tucker presented a packet of expenses.

1. New truck build date is 1-22-25 may have it by the end of February.
2. Lights are in for the new truck and will be sent to NSH for installation on 1-20-25 for \$7055.08.
3. Trucking Radio that needs to be installed will need a faceplate and antenna.
4. Pumps on the truck were not tested, nor was the engine serviced as well. He was not able to work us in December. Can't do a pump test due to being too cold. NFPA requirement temperature must be above 38 degrees. He will come back in March at 200 each truck. He is coming next week if weather permits and service engine and repair packing. Packing repair is \$2000, service cost unknown plus travel time.
5. Tanker lights were ordered and should be here this month.
6. Get SCBA'S tested. \$360 plus travel time.
7. Rit and Air Pacs were ordered in December just a reminder.
8. Order Ellen's boots and gear? \$500.
9. Advertisement for Firehouse Subs grant. I have to check with them first before advertising. Would it be ok to have a banner made if Firehouse Subs agree?

10. A&G new quote

Date of old quote: 4-25-24 \$19,525.77

New bed quote: 1-9-25 \$22,129.39

Difference of \$2603.62

11. Will need to order some gear for Fire fighters. Scott Moore is working on a discounted price from merchandise from last year's turnout gear. The gear would come from FireDex and not match the majority of the gear we have. I have four new firefighters that need complete turnout gear.

12. We had 357 calls for 2024 and 359 calls from 2023

The board approved #2 previously and Chief Tucker was just updating the Board.

The board approved #8 for new boots.

The board approved #10 which was a new quote for the truck bed.

The board did not approve #11, due to the budget. They would like to receive quotes.
